

## Health Department can help residents deal with nuisance wildlife

The surprisingly large numbers of wild animals that call Oak Park home typically keep to themselves. But as winter weather makes their search for food and shelter more difficult, the odds of residents coming into contact with a wild animal increase.

Typically, the biggest problem with wild animals in a dense, built-up community like Oak Park is the property damage they can cause when seeking shelter. Squirrels gnawing a hole in the soffit to get into the attic and raccoons, skunks and opossums burrowing under decks, porches and garage foundations are among the more common nuisance issues property owners face. Even feral cats can cause issues.

Fortunately for residents, the Oak Park Department of Public Health has a Class C wildlife permit from the Illinois Department of Natural Resources. This permit allows the Health Department to lease traps to local property owners who want to try their hand at catching a wild animal rather than hiring a professional service.

Obtaining a trap from the Village is easy. Just visit Village Hall, 123 Madison St., between 8:30 a.m. and 5 p.m. Monday – Friday and complete a short application describing the animal you hope to trap. A cash or check deposit of

\$50 or \$75 is required, depending on the size of the trap. The deposit will be refunded as long as the trap is returned undamaged. The number of traps is limited, so be sure to call and check on availability.

If you catch an animal, the Health Department will dispatch the Village’s Animal Control officer to deal with the trap’s contents. What happens to the animal after it is trapped – whether release or euthanasia – depends on its propensity to spread disease. The Village doesn’t make that decision since state and federal laws govern how to deal with wild animals caught in populous areas.

The Illinois Department of Natural Resources offers extensive information on how to make a property less vulnerable to nuisance wildlife in urban areas, as well contact info for local

nuisance wildlife control professionals – just visit [www.dnr.illinois.gov](http://www.dnr.illinois.gov) and use the search feature.

As for the coyotes and foxes that also call Oak Park home, officials say trying to trap them is difficult at best. Instead, eliminate any potential outside food sources, including unattended small pets.

## Electric vehicle charging stations installed in two public garages

Electric vehicle charging stations have been installed in two Village public parking garages. Chargers are located in the northwest corner on the fourth floor of the Avenue Garage on North Boulevard and just inside the Marion Street entrance on the first floor of the Holley Court Garage downtown. Each station will allow two vehicles to charge at the same time. The charging station in the Avenue Garage is connected to the solar panel array on the roof, providing clean, renewable energy to charge the vehicles. Typically, using a charging station requires a membership in a charging network. However, the Village will allow vehicle owners to use its membership — just ask at the security station in either garage. Officials say that a full recharge would take two to five hours, but most users likely will be just topping off while they shop or run errands nearby. Garage parking rates still apply, but the first hour is free. Parking always is free on Sunday. For more information, e-mail [parking@oak-park.us](mailto:parking@oak-park.us).

### Planning a block party? Know the rules

- Use a north-south block. Due to public safety and traffic considerations, block parties are not allowed on east-west streets.
- Make sure emergency vehicles can get through if needed. Tables, chairs or other items should not project more than six feet from the curb. And don't stretch wires, ropes, nets, lights, banners or other items across the street.
- Supervise children at all times. Even though the street may be closed, accidents can happen.
- Do not plan a party for an alley. Alleys provide important access for utility companies and other services.
- Keep sidewalks clear. Sidewalks are public ways that may not be obstructed even during a block party.
- If alcohol is present, keep it on private property. Alcohol may not be sold.

## Sewer backup protection grant program accepting applications

Applications are now being accepted for a program that provides financial assistance to property owners who install systems to protect their homes from sewer backup during a heavy rain event. Anyone who meets the program guidelines can apply, regardless of income. Work eligible for funding through the Sewer Backup Protection Grant Program includes installing an overhead sewer system or a backflow prevention system. Eligible homeowners may qualify for a grant of 50 percent of the total cost of sewer backup prevention improvements, up to a maximum of \$3,500. ## Life-saving carbon monoxide detectors required by law

An investment of about \$30 for a detector can be the difference in life and death when it comes to deadly carbon monoxide that can leak from a malfunctioning gas appliance such as a furnace or water heater. Because it is impossible to see, taste or smell the toxic fumes, carbon monoxide can kill before you are aware it is in your home. That's why state law requires homeowners and landlords to install carbon monoxide detectors within 15 feet of every room used for sleeping. Alarms can be battery powered, plug-in with battery backup or wired into the AC power line with a secondary battery backup. The alarm can be combined with a smoke detector if the unit complies with established standards and the alarm differentiates the hazard. The property owner must supply and install all required alarms. Landlords must ensure that alarms are operable on the date a lease is initiated. While tenants are responsible for testing and maintaining the alarm after the lease commences, landlords must provide written instructions. Carbon monoxide detectors are not substitutes for smoke detectors, fire officials caution, so both devices are essential. ## Pilot carpet recycling program launched

In an effort to provide a green disposal solution, the Village has teamed up with Indianapolis-based Heritage Recycling LLC to provide curb-side collection and recycling for used carpet and padding. The pilot program, set to launch on March 1, will be similar to the yard and bulk waste sticker programs currently offered. Stickers will cost \$2 each and can be purchased at the Cashier's Office in Village Hall, 123 Madison St. Carpet and padding must be cut or folded into rolls no larger than four feet long and not exceeding 50 pounds each. The rolls should be free of tape, tack strips, nails, knife blades, wet glue and debris, and placed in a dry location such as on or under a porch or in a garage. Pickup will be scheduled by calling the telephone number or visiting the web site listed on the sticker. Each roll will require three stickers. The discarded carpet and pad will be recycled and turned into new products or used as a fuel source. **Multi-family rehab loans...**Owners of multi-family buildings with seven or fewer units may be eligible for forgivable loans of up to \$5,000 per unit and an additional \$2,500 per unit for qualified energy upgrades under the Village's Small Rental Rehab Program. **Single-family rehab loans...**Loans are available to income-eligible residents to correct health and safety issues and building code violations in their single-family homes. The program offers no-interest loans of up to \$25,000 that do not require monthly payments. Loans are repayable after 20 years or when the property is transferred. **Energy, water efficiency rebates and tools...**A Village program funded by the Oak Park River Forest Community Foundation offers rebates to help homeowners reduce energy waste and use. ## Plan for parking when it snows

**R**esidents who rely on on-street parking are urged to monitor local forecasts and plan accordingly when snow is predicted. The Village has specific rules that govern parking when it snows — rules that are enforced seven days a week, including holidays — to ensure streets can be properly plowed. When a snow emergency is declared by the Public Works Department, all parking is prohibited on the main streets posted as snow routes. Parking on other streets is restricted to one side from 8 a.m. until 10 p.m. in residential areas and from midnight to 8 a.m. in designated commercial districts, the side determined by the odd/even date. To find out if snow-related parking restrictions are in effect, call 708.358.SNOW (708.358.7669) for a recorded message. Cable television subscribers can tune into VOP-TV, broadcast on Comcast channel 6 and AT&T channel 99. Residents who sign up at [www.oak-park.us/notifyme](http://www.oak-park.us/notifyme) will be alerted via text or e-mail. **Sidewalk shoveling required...**Property owners who shovel their sidewalks are doing more than making it safer for pedestrians of all ages, they are complying with the law. Village ordinance requires snow and ice to be removed from the public sidewalk within 24 hours following any snow, sleet or freezing rain. Being a good neighbor is important, too, so property owners are urged to help those who may need help clearing a sidewalk. ## Board names Pavlicek Village Manager



**A**fter a national search that attracted 41 applicants, the Village Board in January unanimously approved the selection of Cara Pavlicek to oversee the day-to-day administration of municipal services and programs as Oak Park's Village Manager.

Pavlicek had served in an interim capacity since March 1, 2012 following the resignation of Tom Barwin, who held the post for nearly five years.

Actually, Pavlicek has been with the Village since June 2008 when she was brought in to lead the Parking & Mobility Services Department, which manages a complex system of meters, surface lots, garages and thousands of permits and vehicle stickers.

Officials cited her extensive municipal management experience coupled with hands-on knowledge of Oak Park's many programs and services as being key to making her the perfect candidate to fill the top executive role. Her role in developing the 2013 budget was especially illuminating of her skills, they said.

Prior to coming to Oak Park, Pavlicek served nearly three years as the village manager of Downers Grove. She came to Illinois from Las Vista, Nebraska, where she served eight years as the city administrator following two years as an assistant. She began her municipal government career as an administrative analyst and administrative assistant to the city manager of Des Moines, Iowa.

Pavlicek holds a Master of Arts degree in public affairs from the University of Iowa and a Bachelor of Arts degree in economics from the University of Washington. She also is credentialed by the International City/County Management Association (ICMA), an organization that develops and advances professional local government management.

Oak Park has operated under the village manager form of government since 1953. Under this form of government, a board of elected officials sets policies and hires a professional manager to oversee the day-to-day administration of government services and programs.

Only one other woman has served as Oak Park's village manager, but that was in an interim capacity and for only two-months in 1986. Pavlicek is Oak Park's 10th village manager.
