Village answers call for tornado response help

hen the call went out for help after a late-season tornado swept across downstate Washington in November, Oak Park was among the first to respond. Foresters Dan Bartl and Ron Schwab and mechanics Charles "Rusty" Miller and

Tom Glenn joined responders from across Illinois who rushed to the small town near Peoria to help clean up the devastation the powerful twister had left behind.

Bartl and Schwab brought along Oak Park's specialized log loading truck to help remove debris, while Glenn and Miller were there to ensure the heavy equipment operated around the clock.

These Oak Park Public Works
Department workers answered a call

for help issued through the Illinois Public Works Mutual Aid Network (IPWMAN). This state-wide aid network ensures participating municipalities can rely on each other when emergency response needs exceed a community's resources.

Under the terms of the mutual aid agreement, member communities provide equipment and personnel for up to five days, while the community requesting assistance provides meals, lodging and fuel.

As a member of the IPWMAN, should Oak Park experience a major emergency, the Village could call on other communities to provide similar support.

Once safely back in Oak Park, the Public Works crew shared a similar view on the situation in Washington —

neither video nor photographs could adequately capture just how bad conditions were in the community. All were glad to have been able to help in the cleanup effort.

Overnight parking pass program to expand

ak Parkers soon will be able to request three free passes each month to park overnight on the street and purchase as many as seven passes per month for \$7 each – per vehicle. In addition to increasing the number of available overnight parking passes, an online pass request process also will be offered. The new program is expected to roll out in March. Young bicyclists now required to wear helmets

eollowing a recommendation from the Oak Park Board of Health, the Village now requires bicyclists under age 17 to wear a helmet. Enforcement will focus on education rather than punishment. However, parents of repeat offenders could face a \$25 fine or be required to do community service. The helmet requirement grew from months of study by the Board of Health. whose volunteer membership includes health care professionals. In making their recommendation for the new local law. Board of Health members presented information from the American Academy of Pediatrics. Centers for Disease Control and Prevention and National Highway Traffic and Safety Administration about injuries and deaths caused by bicyclists who have accidents while riding without a helmet. The Health Department has begun working on bicycle safety educational programs aimed at schools and investigating partnerships with local organizations that provide helmets. Concealed-carry law becomes effective

ocal authority over firearms officially ended on Jan. 1 as state concealed-carry legislation went into effect.

Under the new Firearm Concealed Carry Act, the Illinois State Police will issue licenses to individuals who qualify under the legislation to carry concealed firearms. The State Police also are required to maintain a database of licenses and



applications that can be accessed by local law enforcement agencies.

The first licenses are expected to be issued in April.

With limited exceptions, carrying a concealed firearm is prohibited in public buildings and gatherings, including schools, parks, playgrounds and government buildings such as Village Hall.

The law also specifically prohibits concealed firearms in establishments

where more than 50 percent of gross receipts are from alcohol sales.

In addition, single-family homeowners may prohibit people from entering their property with a concealed firearm, and any business owner who posts a sign approved by the State Police may prohibit concealed firearms on his or her premises.

Currently, Oak Park Police are being trained on appropriate enforcement of the new law, given its potential effect on officer safety. Police also are planning to reach out to local business operators and others needing to know how best to handle situations where someone is suspected of carrying a concealed firearm in a prohibited location.

To help interested merchants be prepared by the time licenses are issued, the Village is planning to provide state-approved door decals that let arriving customers know that concealed firearms are prohibited on the premises.

Illinois was the last state to allow concealed carry.

Drivers prohibited from using cell phones

Unless you are using a hands-free device, talking on a cell phone while driving now is illegal in Illinois. Effective Jan. 1, police can stop and ticket drivers using a hand-held cell phone anywhere in the state. Illinois was the 12th state in the country and first in the Midwest to adopt a ban on using a hand-held cell phone

while driving. Fines start at \$75. Illinois already prohibits texting while driving and Chicago has had a ban similar to the new state law on the books for some time. A companion law also increased penalties for drivers who use a cell phone or other electronic device and injure or kill others in crashes. Distracted motorists who harm other drivers now face fines up to \$2,500 and a year of jail time. Drivers involved in fatal accidents could be fined \$25,000 and face up to three years



in jail. With research contending that all cell phone use is equally distracting once a conversation begins, Oak Park Police are urging motorists to put their devices aside while driving. For more information on the dangers of distracted driving, call 708.386.3800 or email **police@oak-park.us**.

17-year-olds eligible to register and vote

egislation that lowered Illinois' voting age to 17 for primary elections went into effect on Jan. 1. Illinoisans born on or before Nov. 4, 1996 can register and vote in the March 18 Primary Election because they will turn 18 by the Nov. 4 General election. The deadline to register to vote in the primary election is Tues., Feb. 18. Voter registration is offered from 8:30 a.m. to 5 p.m., Monday through Friday at Village Hall, 123 Madison St. Voter registration also is available at Oak Park Township, 105 S. Oak Park Ave. Registration requires two types of identification, at least one with the current address. A driver's license or picture ID is preferred, along with an additional item such as a lease or utility bill. Parkway tree trimming begins

Parkway tree trimming is scheduled for early January to mid-March, weather permitting. Trees will be trimmed between Chicago Avenue and



Division Street from East Avenue to Harlem Avenue, and between Division Street and North Avenue from Austin Boulevard to Harlem Avenue. Village crews will prune parkway trees up to 10 inches in diameter, while Winkler Tree Service, working under Forestry Division supervision, will prune larger trees. About 4,500 trees are scheduled to be trimmed. Martin Luther King Day – The Conservatory will be open from 10 a.m. to 2 p.m. on Martin Luther King Day, Mon., Jan. 20.



Forecast key to planning parking when it snows

The Village has specific rules that govern parking when it snows — rules that are enforced seven days a week, including holidays. Residents are urged to monitor local forecasts and plan accordingly. When a snow emergency is declared by the Public Works Department, all parking is prohibited on the main streets posted as snow routes. Parking on other streets is restricted to one side from 8 a.m. until 10 p.m. in residential areas and from midnight to 8 a.m. in designated commercial districts, the side determined by the odd/even date. To find out if snow-related parking restrictions are in effect, call 708.358.SNOW (708.358.7669) for a recorded message. Cable television subscribers can tune into VOP-TV, broadcast on Comcast channel 6 and AT&T channel 99. Residents who sign up at www.oak-park.us/notifyme will be alerted. New law limits free parking for persons with disabilities

ffective Jan. 1, a disability parking placard will no longer automatically qualify for meter-exempt parking. Only individuals with a specific meter-exempt permanent placard will not have to pay parking meter fees. These placards are issued to persons with permanent disabilities whose physician-certified impairments make it difficult to access a parking meter. The authorized holder is exempt from parking meter fees and time limitations at parking meters that exceed a 30-minute time limit. An individual with a disability license plate still will need an exempt placard to have meter fees waived. Other types of placards, including temporary and organizational placards, are not exempt from meter fees, but allow parking in spaces reserved for persons with disabilities. Prescription drug disposal offered



rescription drug collection is available in the lobby of the Police Department at Village Hall, 123 Madison St. A secure drug collection container, which functions like a postal box, was purchased using a grant from the Illinois EPA. The box can hold up to 50 pounds of material. Needles or other medical waste are not accepted. Police personnel dispose of the drugs in accordance with established procedures. Safe disposal of drugs is becoming increasingly important, as trace residues of some medications can turn up in the water supply from flushing of unwanted prescription drugs. CPR classes offered

he Oak Park Fire Department offers a variety of life-saving classes including CPR and training in how to use an automated external defibrillator, or AED. Classes are held from 6 - 10 p.m. at the Fire Department's certified American Heart Association community training center in the main station, 100 N. Euclid Ave. All courses are taught by an AHAcertified instructor. Classes are \$25 for Oak Park residents and \$50 for nonresidents, plus a \$12 textbook fee. The healthcare provider course is \$40 for residents and \$60 for non-residents, plus a \$12 textbook fee if required. Payment must be made by check, money order or cash in exact amount. In-person registration is required. Class size is limited to eight students for infant/child classes and nine students for all other classes. Annual report available – Oak Park Township accomplishments and finances for April 1, 2012 – March 31, 2013 are available for citizen review at **oakparktownship.org**. Highlights for the year include:

- New Senior Services facility opened to provide nutrition, transportation and other support to help senior citizens maintain their independence.
- Youth Services introduced FACE IT, a program to guide youth away from alcohol and drug use through education in a supportive group setting.
- **Financial and job search assistance** declined from the 2011–12 high to less than 100 per month due to improved post-recession employment opportunities.

Innovation award – The Township Officials of Illinois awarded its 2013 Innovative Senior Program Award to Oak Park Township for the book *SPREAD*, an intergenerational effort to preserve the memories and stories of seniors gathered at the Townships' daily lunch program. Created under the guidance of DePaul College Professor Jim Duignan and students from Oak Park and River Forest High School, interviews were transcribed into an anthology of stories. New director to lead re-organized development department



veteran public servant with two decades of experience in law, housing and development grants has been tapped to head up a newly re-organized department to deliver business development and customer services. Tammie Grossman will become director of the Community & **Economic Development Department** on Jan. 6. An Oak Park resident for more than 15 years, she served as manager of the Village's Housing and Community Development Block Grant programs and interim director of human resources. Grossman's appointment came as the Village restructures its building, business

services, housing and planning operations into a single department to streamline and improve customer services. The new position will serve as the primary point of contact for all development efforts, and Grossman will be the liaison between Village Hall and the development community. The Village Board likely will rename the department, but duties will remain focused on serving Oak Park's development and business community. Grossman, who has a law degree from DePaul University and a political science degree from Northern Illinois University, was selected from a pool of more than 100 candidates. During her five years at the Village, Grossman's accomplishments included a complete transformation of the housing department refocusing efforts on its core mission and securing outside funding for new programs. She also spearheaded the creation of the West Cook County Housing Collaborative, which has secured more than \$14 million for Oak Park and nearby communities. Grossman took over supervision of the Village's CDBG program in 2012 and served as interim HR director following the retirement of its previous director in July 2013. Before joining the Village, Grossman worked as an attorney in housing and urban development and served as executive director of Housing Action Illinois.
